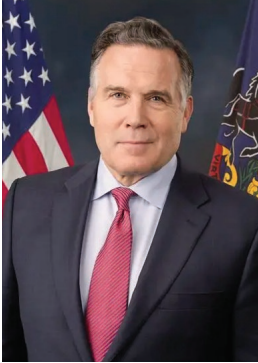

Threats from Above New Frontiers in Aviation Security

With new developments in Ukraine and the Middle East, and rapidly evolving technologies in aircraft, aircraft control systems, and communications, the attack space for aviation security is evolving rapidly. This panel will identify and discuss some of the emerging issues, ranging from securing communications in our air traffic control system, to ensuring information integrity in traffic and navigations systems to airspace awareness and detection and counter-UAS approaches.

The discussion begins by examining the most pressing and emerging issues in aviation security, highlighting the topics that are currently shaping the field. Panelists then turn to the challenges of securing aviation communications and information systems, focusing on maintaining integrity, resilience, and trust in increasingly complex and interconnected environments, while also considering practical solutions.

Another key area of focus is improving airspace awareness—understanding who and what is operating within increasingly crowded skies—and how this directly supports counter-UAS (unmanned aircraft systems) efforts. The panel also considers the broader implications of national counter-UAS strategies.

John S. Eberhardt III is Managing Director of ATA Aviation, where he leads the development of advanced technology solutions across the aviation, defense, healthcare, security, and biotechnology sectors. With more than 25 years of experience managing multidisciplinary teams of scientists and engineers, he has overseen the delivery of data-sharing platforms for federal agencies, streaming data systems for commercial aviation, clinical decision-support tools, and logistics analysis applications.

He holds three patents, has multiple patent applications, and has authored more than 50 publications and invited presentations on advanced systems and emerging technologies.

Driving the Surge of AI-Driven Digital Infrastructure in Pennsylvania

Artificial intelligence–driven data center growth is intensifying national competition for digital infrastructure, placing Pennsylvania at a strategic crossroads. This session explores how hyperscale, AI-dense facilities are reshaping energy demand, grid readiness, site development, and permitting timelines—and what the state must do to compete with market leaders such as Virginia. Panelists will examine the engineering realities of high-density compute, the critical role of power availability and interconnection, and the policy and regulatory changes needed to accelerate development.

The discussion will also explore how Pennsylvania’s manufacturing base, skilled workforce, and brownfield assets, including sites like Homer City, can be repositioned as competitive advantages. Attendees will leave with a clearer view of the barriers slowing AI-scale infrastructure, the emerging opportunities across the supply chain, and the specific actions state leaders, utilities, developers, and economic development organizations can take to attract the next wave of investment.

The conversation will highlight strategies to overcome these barriers, showcase emerging innovations, and outline approaches to modernizing manufacturing practices—ensuring naval forces are prepared to meet the demands of both current and future security environments.

Col. Kenneth A. “Andy” Stremmel is the Commander, National Air and Space Intelligence Center, Wright-Patterson Air Force Base, Ohio. 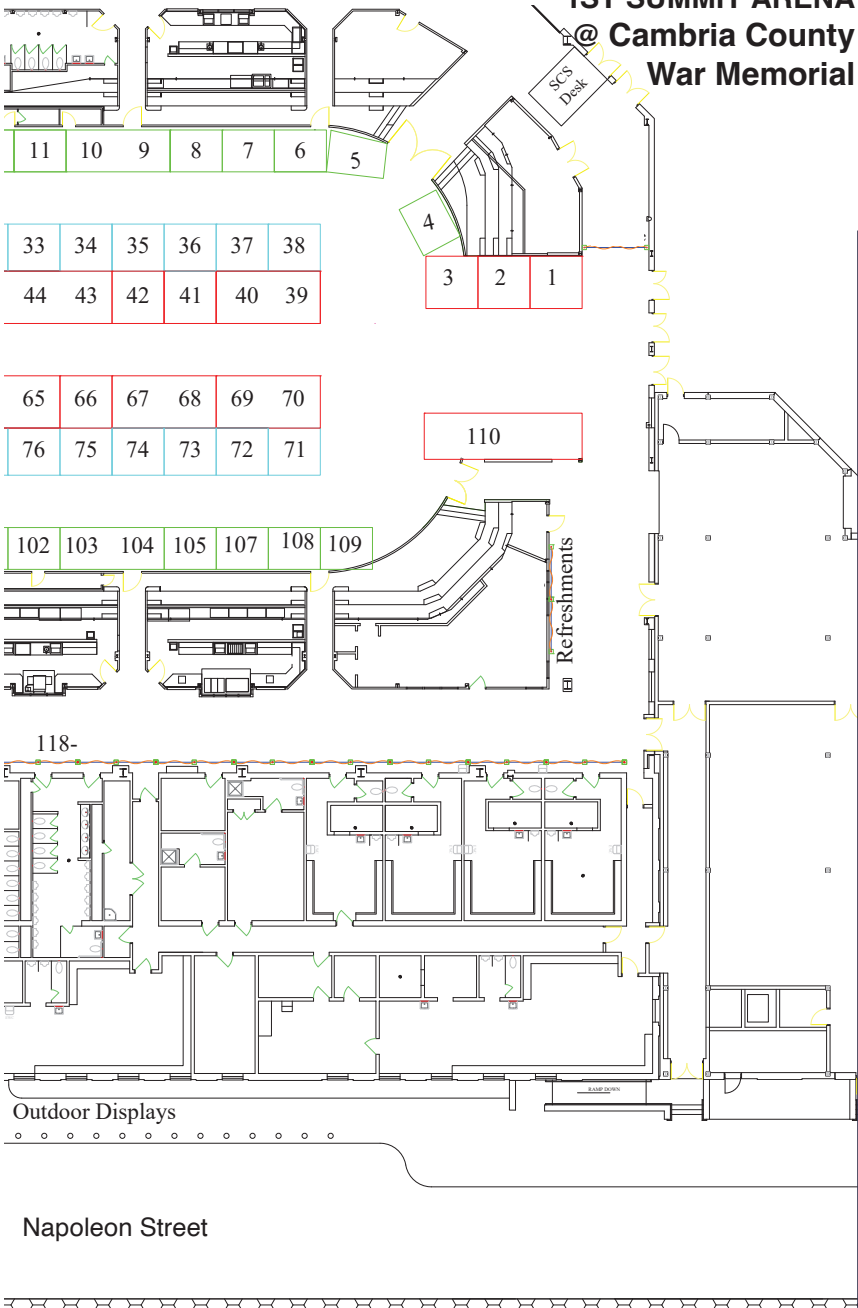
